##### ALL FEES ARE PAID IN MONTHLY INSTALMENTS BY STANDING ORDER

Executive Members: £3,800 + VAT per annum, which is invoiced quarterly in advance.

Executive Members are ultimately responsible for setting the strategy, objectives and policies for the Association. The Executive meets every 12 weeks and receives input from working groups on policies and proposals. Executive members may sit on any working group and use the Executive logo

Executive membership is for Government appointed Accreditation Schemes

Associate Members: £2,000 including VAT per annum

Associate Members have input to Strategy, Objectives and Policies and will have quarterly meetings. Associate members can sit on working groups.

- Any exception to any of these rules must be expressly agreed by the Board and recorded in writing
